**WHEREAS**, the City of Venus ("City"), Texas is Type A General Law municipality located in Johnson and Ellis Counties, Texas organized under the laws of the State of Texas;

WHEREAS, the City is required to strictly adhere to a municipal budget and to allocate funds to the necessary priorities of the City;

WHEREAS, the Venus City Council ("Council") has a duty to respond to emergency circumstances when they arise whether to maintain the delivery of vital city utility services, to provide shelter to displaced citizens, to repair or replace technology destroyed by a storm, fire or otherwise, to address any unusual occasion or instance, unforeseen and/or unanticipated, for which the City is required to expend funds in its effort to save lives and to protect property, public health and safety or to lessen or avert the threat of catastrophe or major disaster, or for any other emergency/disaster related expense;

WHEREAS, the City budgets annually a reserve amount for such emergencies;

**WHEREAS**, city staff recommend a reserve emergency fund account be created separate from the general fund account to allow these funds to accrue budget year to budget year;

**WHEREAS**, the Council finds it is in the best interest of the citizens and taxpayers to create this account as provided herein.
