ITEM 11 PRESENTATION BY DANNY MARSCHALL ON THE PROPERTY AT 211 S. WALNUT ST. IN VENUS.

Danny Marschall presented to the council his concerns regarding issues he has that pretain to the property donated to the city to build Shana's Park and his property at 211 S. Walnut Street in Venus. Mr. Marschall explained he has no access to his property's location. He is concerned that the citizens will be walking on his lot and could fall and trip and that would be a lawsuit for him. He would like the city to build a fence, a culvert or purchase his propety for \$30,000. Mr. McCurdy asked Mr. Marschall if building a fence would possibly be an issue because that would also block Mr. Marschall from accessing his propoerty as well. Mr. McCurdy also explained that Mr. Marschall has access through the alley way. Mr. Marschall responded saying he does not want to go through other people's property to access his property.
