



**RESOLUTION NO. 07-2017-04**

**A RESOLUTION OF THE CITY OF VENUS, TEXAS, APPOINTING ELECTION JUDGES FOR THE SATURDAY, MAY 6, 2017 SPECIAL ELECTION AS PROVIDED BY THE JOHNSON COUNTY ELECTIONS OFFICE AND THE ELLIS COUNTY ELECTIONS OFFICE FOR EARLY VOTING AND ELECTION DAY AND ORDERING THE CITY SECRETARY TO PROVIDE NOTICE OF THIS RESOLUTION TO BOTH THE JOHNSON COUNTY ELECTIONS AND THE ELLIS COUNTY ELECTIONS OFFICES.**

**WHEREAS**, the City of Venus (“City”), Texas is Type A General Law municipality located in Johnson and Ellis Counties, Texas organized under the laws of the State of Texas;

**WHEREAS**, the Venus City Council (“Council”) has ordered there to be a special election for May 6, 2017 to put to voters a ballot proposition regarding tax relief;

**WHEREAS**, the Council has approved and contracted with the Johnson County Elections office and the Ellis County Elections office to conduct said special election;

**WHEREAS**, the TEXAS ELECTIONS CODE Section 32.008(a) directs Council to adopt by written order (resolution) the appointment of election judges for the election;

**WHEREAS**, the appointment of said election judges is for a single election as provided by TEXAS ELECTIONS CODE Section 32.005(a), not a term;

**WHEREAS**, the Johnson County Elections and Ellis County Elections offices are administering said election, they have provided the names of election judges for early voting and election day to the City for Council consideration and appointment;

**WHEREAS**, Council finds the names provided to be acceptable and worthy of appointment and made in accordance with the law and with the election agreements previously executed; and

**WHEREAS**, the City Secretary, Rana Gamel, recommends Council appoint said election judges as provided by the Johnson County Elections office and the Ellis County elections office.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF VENUS, TEXAS:**

**SECTION 1.**

Council finds all of the recitals listed within this resolution to be true and correct and the basis of the Council's decision.

**SECTION 2.**

The Council hereby appoints election judges for the Saturday May 6, 2017 special election as follows:

**Ellis County:**


**SECTION 3.**

Council directs the city secretary to provide notice of Council's appointments to both the Johnson County Elections and Ellis County Elections offices.


**SECTION 4.**
